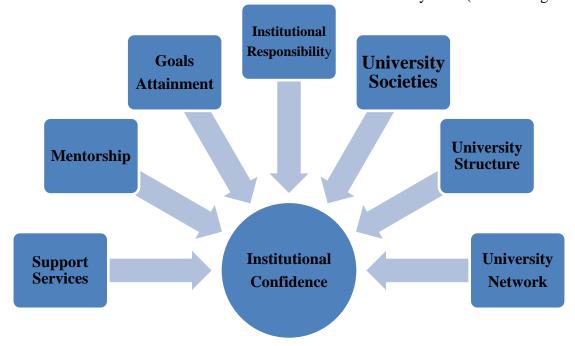


Figure 1: Institutional confidence in Nigeria university education

In consideration of the above as a problem in Nigeria Universities and in an attempt to proffer solutions to it considering the relevance, the Federal Government, University administrators, university consumers and stakeholders must work toward achieving goals and enhancing performance in the university by developing confidence in the university.

Adegbesan (2010) posits that much research has demonstrated that retention and the quality of education depends primarily on the way universities are managed, more than the abundance of available resources, the capacity of universities to improve teaching and learning is strongly influenced by the quality of the leadership provided. Concerted effort to improve university leadership is one of the most promising points of intervention to raise retention, the quality and efficiency of university education across Sub-Saharan Africa.

Over the past "decade researchers have to identify factors/characteristics of effective leaders, point out values such as honesty, integrity, trust, care and compassion. The search for authenticity, integrity and trust in and among members within institutions is very much a reality. CONCLUSION
