#### THEORETICAL BACKING

This paper was anchored on two theories, contingency and situational theory.

# **Contingency Leadership Theory**

Proposed by Fred Fiedler in the 1960s, the contingency theory states that there is no one-size-fits-all approach to leadership and that effective leadership depends on the interplay between leadership style and situational variables (Fiedler, 1964). According to contingency theory, different leadership styles may be more effective in certain situations, and the key to leadership success lies in adapting leadership styles to the specific needs of a situation (Northouse, 2021).

In the context of coordination mechanisms, contingency theory suggests that leaders should tailor leadership behavior to the specific needs and characteristics of their institution. For example, in schools with highly structured and rule-bound environments, a directive leadership style may be more appropriate as it provides clarity and direction to followers (Yukl, 2013). On the other hand, in schools that encourage innovation and creativity, a more participatory and collaborative leadership style is beneficial in fostering collaboration and empowerment (Bass & Riggio, 2006).

Contingency theory emphasizes the importance of assessing the advantages of a situation for leaders. Likeability is determined by her three key factors .Leader-member relationships, mission structures, and positional powers (Fiedler, 1964). The situation is considered more favorable for leadership effectiveness when the relationship between the leader and members is good, tasks are well defined, and the leader's positional authority is high. In such situations, adjustment mechanisms can focus on exploiting existing favorable conditions to maximize organizational effectiveness.
