However, leadership involves types of responsibility aimed at achieving particular ends by applying the available resources (human and material) and ensuring a cohesive and coherent organization in the process (Ololube, 2017), while management is seen as the mobilization of both the human and the material resource aspects of organizations towards the achievement of goals (Ololube, 2019).

Many fields of study, including sociology, psychology, business, and economics, have delved into the many elements of leadership. Robbins and Coulter (2017) defined management as the 'planning, organizing, and regulating of resources' that directs an organization towards its goals. Management comprises identifying tasks and carrying them out. The manager's duties include decision-making, resource allocation, and daily operations management. Management quality is the single most important factor in organizational performance, longevity, and financial viability (Hitt et al., 2018).

Leadership and management have the same goal of making their organization successful, but they go about it in very different ways and get different results. Leaders that are able to inspire their colleagues while still forging their own path typically do well (Kotter, 1996). True leaders are those who can see success for their organizations and communicate that vision to others (Bennis, 2007). They foster an atmosphere conducive to innovation and development by rewarding and praising originality, flexibility, and progress. In contrast, the focus of management is on optimizing resources to accomplish desired outcomes. Bateman and Snell (2019) stated that managers prioritize process design, arrangement, and control to guarantee effective action that leads to desired outcomes. They legislate and institute measures meant to ensure achievement. When it comes to dealing with people, leadership and management are two very different ballgames. According to Yukl (2013), one of a leader's most important jobs is to help their subordinates grow and become self-sufficient. Leaders encourage their followers to grow personally and professionally. Each member of the team needs to contribute to the team's success (Chemers, 2002).

Leadership considers the big picture and how everything works together, while management pays attention to the nuts and bolts of getting things done. For successful managers, success is accomplishing their goals. They are responsible for allocating resources, assigning work, and keeping tabs on its progress (Robbins & Coulter, 2017). Leadership and management play complementary but distinct roles in ensuring an organization's success. Management comprises planning, organizing, and coordinating resources to meet organizational objectives, whereas leadership entails inspiring and motivating others towards a shared cause. While management is concerned with the big picture, leaders tend to prioritize day-to-day tasks like efficiency and stability. To make the most of the possibilities offered by each role, it is essential to understand the distinctions between a leader and a manager.

Definitions of Leadership

- 1. Kruse (2013) stated that leadership is social influence that amplifies the efforts of other people to achieve a common objective; this definition highlights the value of influence and the benefits of leveraging the efforts of others to attain one's own goals.
- 2. According to Northouse (2018), great leaders inspire their teams to work together for the greater good. The ability of a leader to motivate their team to work together is highlighted here.
- 3. According to Yukl (2013), leadership is the activity of convincing others to grasp what needs to be done and agree on how to accomplish it and then work together to reach those goals. This definition places a focus on the need of open lines of communication and teamwork in the workplace.
- 4. Kouzes and Posner (2017) presented a definition of leadership that centres on the ability to inspire one's team to fight through adversity and cooperate for the greater good.
- 5. To Daft (2015), a leader is someone who leads and convinces others so that they work together to attain a shared purpose. This emphasises leaders' competence in guiding others in their care.
- 6. According to Avolio and Yammarino (2013), leaders change the world through inspiring their followers to take positive action. According to this view, a leader's role is to motivate their followers to achieve their full potential.
- 7. According to Bennis (2007), a leader is someone who helps the group get closer to its objective. This theory of leadership places a premium on being able to see success for one's followers and then guiding them there.
- 8. To House et al. (2004), leadership is the capacity to rally on others in pursuit of a common purpose. According to this hypothesis, a group will achieve more success if its members are more enthusiastic about helping the group's leader.
- 9. Leaders, as defined by Chemers (2002), they inspire their followers to work together towards a single goal. An effective leader, in this opinion, is one who can motivate subordinates to work towards a common objective.
- 10. Bass and Riggio (2006) stated that a great leader is one who creates a compelling vision of the future and motivates their people to work diligently to make it a reality. A leader is someone who inspires followers to act now in order to make tomorrow better.
- 11. According to Tannenbaum et al. (1961), leadership is the ability to persuade people to work together towards a single goal, which involves the ability of leaders to share their vision and inspire their followers to act on the goal is emphasised.
- 12. The capacities to manage a group, gain support, and persuade followers to take action are all hallmarks of leadership, as described by Kotter (1996). A leader in this context is someone who motivates their team to go the additional mile.
- 13. House and Mitchell (1974) defined leadership as the process of influencing the conduct of others to attain a common purpose emphasises the leader's responsibility to inspire and direct the team to victory.
- 14. Leadership, according to Hogg et al. (2010), may be seen of as using one's influence to get one's followers to do something. The emphasis is that leaders should prioritise both facilitating and directing tasks.

- 15. Smircich and Morgan (1982) argued that effective leaders are those who can convince their followers of the critical nature of the organization's goals. It is the leader's responsibility to rally their troops to victory.
- 16. According to Hater and Bass (1988), leadership is the ability to change the attitudes and actions of those one manages. This theory emphasises the effect leaders have on the feelings, choices, and actions of their followers.
- 17. According to Conger (1992), one measure of a leader's performance is the degree to which he or she gains the trust and cooperation of those who must work together to fulfil the organization's goals. It is the leader's responsibility to ensure that everyone is on the same page so that they can effectively collaborate.
- 18. House, Spangler, and Woycke (1991) listed a number of qualities shared by successful leaders, such as the ability to steer individuals and organizations towards agreed-upon goals and the charisma to motivate followers to adopt the leader's vision. The need of a visionary leader who can galvanise their team around a shared objective is emphasised.
- 19. Hackman and Johnson (2009) argued that leaders have the responsibility to help their teams achieve success.
- 20. Hollander (1978) argued that leaders are those who mobilise followers to take action in pursuit of a shared vision. This tactic stresses leader's and people abilities while encouraging subordinates independence.
- 21. According to Kouzes and Posner (2017), effective leaders are those who can convince their followers that following their example would improve their collective prospects. The importance of leaders providing a compelling vision that inspires their followers to act is emphasised.
- 22. For a leader to succeed, they must be able to rally their followers behind a common cause (Mullins, 2016). This concept emphasises the role of the leader in inspiring their group to work together effectively.
- 23. According to research by House et al. (2004), leaders are individuals who motivate their teams to cooperate in order to achieve a common goal. Leadership, in this context, is inspiring one's subordinates to perform to the best of their abilities.
- 24. Bass (1990) saw leadership as those who can motivate their followers to do new things. Thus, good leaders can inspire their group or organization to make major structural adjustments.
- 25. To Graen and Uhl-Bien (1995), leadership is the process of influencing the activities of an individual or group in efforts towards goal attainment in a given context, which highlights the importance of a leader's ability to encourage and direct followers towards a common target.
- 26. According to Choi and Ruona (2011), leaders require the capacity to rally one's subordinates around a common cause.
- 27. Robbins and Judge (2017) argued that effective leaders are those who can unite their people under a shared vision. This concept emphasises the value of the leader's authority in directing the team to victory.
- 28. According to the work of Goffee and Jones (2000), leaders motivate their teams by offering both direction and an exemplary example. A leader is someone who motivates their followers to perform at their best and strive to achieve the same level of achievement they have.

- 29. To Bass and Bass (2008), leadership comprises inspiring subordinates to adopt one's long-term goals and tactics through a combination of personal inspiration and group solidarity. The ability to rally followers around a common goal is central to this view of leadership.
- 30. According to Koontz and Weihrich (2010), leadership is the ability to inspire others to take action by one's own behaviour as an example. This concept emphasises how respect and cooperation from one's subordinates are hallmarks of good leadership.

Definitions of Management

All facets of management are described here, from preparation to implementation, from resource allocation to outcome attainment:

- 1. Robbins and Coulter (2017) defined management as the activity of preparing for and controlling the activities of workers to fulfil the objectives of an organization.
- 2. To Drucker (1954), management is the art of getting things done via people, with an emphasis on harnessing the power of those one works with to achieve goals.
- 3. According to Bateman and Snell (2019), management is the process of planning, organising, directing, and managing resources achieve desired results. Planning, organization, leadership, and control are the four pillars of management that are included into this concept in order to optimise output and accomplish set objectives.
- 4. Weihrich and Koontz (1993) described management as the art and science of getting things done by influencing people to get what you want done inside an organization. Since management is ultimately a team effort, successful corporate leaders need to engage and inspire their employees.
- 5. According to Stoner et al. (2009), management is the process of guiding an organization to success via the combined efforts of its many parts. The key premise is that leadership should foster a team mentality throughout the workforce.
- 6. Hellriegel et al. (1998) defined management as the procedure whereby an organization figures out what it needs and where to put its resources to get it. The ability of managers to guide and monitor employee efforts to achieve organizational objectives is central to this concept.
- 7. To Lussier and Achua (2019), management is the art and science of coordinating the activities of numerous persons towards a single aim.
- 8. To Hitt, Ireland and Hoskisson (2018), the role of management is maximising the use of available resources towards the accomplishment of organizational objectives.
- 9. Ivancevich, Konopaske and Matteson (2019) described management as the process of controlling and regulating resources to meet an organization's goals.
- 10. To Hitt, Black and Porter (2017), management is the process of organising and directing people to meet an organization's objectives.
- 11. According to Rue and Byars (2018), management is planning, organising, leading, and controlling the actions of members of the organization to achieve the specified objectives.
- 12. Mullins (2016) defined management as the art of making the most of constrained resources to fulfil strategic objectives. It emphases the importance of a manager's capacity to optimise results while working within resource constraints.
- 13. To Kinicki and Williams (2020), management rests on the five pillars of planning, organization, personnel, leadership, and control.

- 14. Wren, Bedeian, and Breeze's (2002) defined management as the activity of coordinating and monitoring, these responsibilities highlights the significance of management in steering people towards organizational goals.
- 15. Gryphon and Moorhead's (2014) defined management as the activity of working with and through people to adapt to changing circumstances and achieve the aims of an organization. This definition highlighted the mutual dependency of superiors and those under their charge.
- 16. According to Cole and Kelly (2015), management is the process through which an organization plans, organises, leads, and manages its resources to achieve those objectives. Management involve in maximising the effectiveness of time, money, and other resources spent on attaining corporate goals is highlighted by this idea.
- 17. To Luthans (2016), the discipline of management is the art of coordinating the activities of many people and organizations to achieve a common objective.
- 18. According to Ololube (2017), management is the process of utilising organizational resources to achieve predetermined goals by planning, organising, directing, and controlling activities.
- 19. According to Longenecker et al. (2011), management is the process of directing a group or organization towards its objectives through the combined efforts of its members. This highlights the importance of managers in facilitating team success.
- 20. To Schermerhorn et al. (2011), management is the act of allocating, coordinating, and controlling an organization's resources in order to bring about the desired results.
- 21. According to Kinicki et al. (2018), management is the action of organising and directing people to meet organizational aims.
- 22. Hitt et al. (2019) defined management to entails all of a manager's responsibilities, from planning and organising to implementing and assessing, in order to achieve the goals of the organization.
- 23. Williams et al. (2019) definition places premium on management as the practise of coordinating and supervising others' efforts to ensure the organization's goals are met in the most efficient and effective manner possible.
- 24. Hill and Jones (2017) defined management as the process of integrating and deploying organizational resources to attain desired objectives. It focus on the manager's role in making the connections.
- 25. According to Ivancevich et al. (2017), management can be defined as "the art of coordinating and directing the efforts of individuals and groups towards the achievement of organizational goals and objectives," highlighting the importance of managers' abilities to effectively coordinate and direct employees towards the achievement of organizational goals and objectives.
- 26. According to Coulter et al. (2012), this definition covers the managerial process of planning, organising, directing, and regulating resources in an efficient and effective manner to fulfil the organization's goals.

Credibility is often the key to leadership positions, as trust is fundamental to all types of organized human groups, including education, business, the military, religion, government, and international organizations (Lamb & McKee, 2004; Ivancevich et al., 2007).

Leadership entails a type of responsibility aimed at ensuring organizational cohesion and coherence while utilizing available resources (both human and material) to achieve specific goals. Northouse (2007) described leadership as the process by which individuals influence groups of people to achieve common goals. This chapter shows that effective leadership is essential to the proper operation and survival of nonprofit organizations. 


Figure 1: Qualities of the leader and the manager. Source: Naylor (1999: 524) in Ololube (2017, p. 90)

They make informed choices based on evidence, weigh the pros and cons, and aim to maximize organizational outcomes (Pfeffer & Sutton, 2006). Rational managers avoid impulsive or emotionally-driven decisions and strive for objectivity in their actions, ensuring a systematic approach to problem-solving. Managers possess a diverse set of core qualities that enable them to effectively lead and manage teams. These qualities encompass rationality, consulting, persistence, problem-solving ability, tough-mindedness, analytical thinking, a structured approach, deliberation, authoritative demeanor, and a stabilizing influence. By leveraging these qualities, managers can navigate challenges, make informed decisions, and ensure the smooth functioning of the organization:

- Rational: Rationality is a fundamental characteristic of an effective manager. They are expected to make logical and informed decisions based on objective analysis and evidence. Rationality enables managers to critically assess situations, evaluate available options, and select courses of action that maximize organizational efficiency and effectiveness. Ololube (2017) argued that managers need to demonstrate bounded rationality given the limitations of time, information, and cognitive capacity. A rational decision-making process helps managers minimize bias and make informed decisions consistent with organizational goals and objectives.
- Consulting: Consulting is a key quality that enables managers to tap into the collective knowledge and expertise of individuals and groups inside and outside the organization. Effective managers actively seek opinions, listen to different perspectives, and consider different perspectives before making decisions. Consulting improves the quality of decision making by incorporating broader insights and minimizing the risk of missing important information. Hit et al. (2019) emphasized the importance of involving stakeholders in the decision-making process to gain support and build consensus. By consulting others, managers can leverage the expertise of employees, colleagues and external partners, leading to more informed and comprehensive decision making.
- **Persistent:** Perseverance is an important trait for managers who work towards overcoming challenges and achieving organizational goals. Along the way, managers face setbacks and obstacles, but perseverance helps them stay true to their goals. Ololube (2017) argued that stubborn managers demonstrate resilience, perseverance, and determination to overcome hurdles and sustain progress. They inspire teams by demonstrating a strong work ethic and can-do attitude, and by being examples of resilience and perseverance. Tenacious managers know that achieving long-term success requires continuous effort and dedication in the face of adversity.
- **Problem-Solving:** Problem-solving is a core competency of managers as they face various problems and complexities in their role. A competent manager is able to identify problems, analyze their causes and develop appropriate solutions. Daft (2014) emphasized the importance of critical thinking and creativity in problem solving. Managers gather relevant information, evaluate alternative approaches, and take steps to address challenges. They apply systematic problem-solving techniques to ensure

- thoroughness and effectiveness. Good problem-solving skills enable managers to solve problems in a timely and efficient manner, contributing to organizational effectiveness and efficiency.
- Tough-minded: Perseverance is a trait that enables managers to make difficult decisions, handle conflicts, and provide constructive feedback. Bass and Riggio (2006) argued that stubborn managers put organizational interests ahead of personal biases and feelings. They show courage and resilience in dealing with difficult situations and stay true to their beliefs. Tenacious managers know the importance of enforcing standards, maintaining accountability, and resolving conflicts to ensure the success of their organization. Your ability to make difficult decisions and handle difficult situations helps maintain a healthy and productive work environment.
- Analytical: Analytical thinking is an important trait for managers because it enables them to gather and analyze information, identify patterns, and make data-driven decisions. Robbins and Judge (2017) emphasized the ability of analytics managers to process complex data, interpret trends, and derive meaningful insights. They use analytical tools and techniques to assess organizational performance, identify opportunities for improvement, and drive strategic decision-making. By applying analytical thinking, managers can manage uncertainty, anticipate potential problems, and make informed decisions that align with organizational goals.
- Structured: Leaders bring structure to their work and to their entire organization. They set the framework, make plans, and allocate resources systematically. A structured manager defines clear roles and responsibilities, establishes processes and procedures, and ensures that tasks are carried out efficiently (Robbins & Coulter, 2017). Studies have shown that organizations with well-defined structures achieve better performance and better outcomes.

Authoritarian managers create a sense of order and stability and inspire trust among employees (Yukl, 2013).
